Scholarship Guidelines 2021

We are so pleased that you are interested in the Jewish Community Center (JCC) and our programming. We do our best to meet the needs of all families requesting financial assistance but we are limited by the amount of money available for financial assistance and by the number of requests received.

Applications will be accepted for **Membership dues, Early Childhood Center (ECC) tuition, Camp K'Ton Ton fees, Bernie Camp fees and Club J Afterschool fees**. Extended care, overnight camp and other add-ons are excluded. All other programs are also excluded.

Scholarship recipients are required to have an active JCC membership, which requires an initial 1-year commitment. We also require registration for the programs you are requesting assistance for and payment of registration fees. Before submitting your application, please join the JCC and complete the program registration online or in-person.

We will give every consideration to your request as long you meet the requirements outlined in this letter and submit the following:

- Completed application
- Copies of your 2020 filed tax returns (Federal, State and Local)
- Copies of your most recent paycheck stub(s)
- Verification of other sources of income
- Profit and Loss statement (if self-employed)
- Personal statement indicating how you and/or your family would benefit from receiving financial assistance from the JCC. Please be specific. Include mention of any special circumstances which may affect your need for financial assistance.

ALL APPLICATIONS ARE DUE NO LATER THAN FRIDAY, APRIL 23, 2021

- Failure to include verification of your income by providing copies of the information requested above will result in your application for financial assistance being denied.
- If you are divorced- indicate how much you receive in alimony and child support. If you do not receive alimony or child support, please explain why you do not receive this support.
- If your child's other parent is deceased or disabled please include amounts received for support from Social Security.
- **Applicants MUST have a \$0 balance at the JCC** prior to the application deadline of April 23, 2021. Any applicants with outstanding balances will not be considered for a scholarship.

Attached is our financial assistance scale as a guide for the discounts we provide based on income and family size. **The scale is not a guarantee**. Awards depend on scholarship funds raised and the number of applicants. We take into consideration individual circumstances

which may result in awards that do not match the scale. ***If there are extenuating circumstances which should be considered in making a determination for financial assistance for you and your family, please provide this information in your personal statement which must be a part of every application for scholarship assistance.***

We expect to make the award decisions by the last week of May. We will need your prompt reply to the offer letter, especially if you are enrolled for summer programs.
